Click Save and choose a folder on your hard drive to hold the compressed report file.

Unpacking\Decompressing instructions:

Unpack your report results by double clicking your report file, "VoterList.47560.021521091257.zip", which will then guide you through the unzipping process. During this process you will be able to select the location on your hard drive where your results will be unzipped to. Select a folder where you can easily find these results later. There may be more than one report results file depending on your file type and result columns selected. To view the exact number of files and the names and format of each file in your report, return to the SOS Services web site where you created your report and click the "View Selected File Structure" button on the General tab of this report. Open the unzipped file(s) to view the report results.

You have 7 days to retrieve the compressed report file at which point it will be removed from the server and no longer downloadable from this location.

By submitting the Request for List of Registered Voters, all users acknowledge that any improper use of the information compiled in the statewide voter registration database may constitute a felony pursuant to NRS 239.330.



All Reports generated will reflect voter registration data captured and maintained by the respective counties. Maintenance on all voter registration data is conducted at the county level and is therefore subject to the individual county procedures. All inquiries regarding specific voter registration data should be directed to the respective county registrar/clerk.


If any questions arise regarding particular registration dates in regards to specific individuals, please contact the respective county clerk/registrar for clarification. It is possible that the registration date shown may not reflect the individual's original registration date in Nevada due to relocation between counties and other updates to voter registration records.

Statewide Voter Registration List

NevVoter is a centralized statewide voter registration system maintained by the Office of the Secretary of State. The system provides information relating to registered voters throughout the State of Nevada. The county clerks and registrars from Nevada's seventeen counties provide information relating to the registration status of all eligible citizens throughout the state. The submitted information is then compiled and verified by this office in accordance with state and federal election laws.

The statewide voter registration database is publicly accessible through this office and available in either hard copy or by a variety of electronic formats. NevVoter is accessible to the public; however, the Office of the Secretary of State retains full authority in granting, denying or revoking access at any time, in accordance with applicable local, state and federal law or regulations.

Requesting access to the Statewide Voter Registration List is a **two-step** process. You must complete both steps before accessing the Statewide Voter Registration List:

Step 1: The applicant must [create a web account](#) within the Nevada Secretary of State Online Services portal (see **Additional Resources** below for step-by-step account creation instructions).

Step 2: The applicant must download and submit an [Official Request for List of Registered Voters Form](#). This form must be completed, signed, and filed with the Secretary of State. Additionally, submission can be made via email, fax, mail or by personal delivery during regular business hours.

Qualification of the applicant to access the statewide voter registration list will be verified upon the filing of a completed request form. Once access has been granted, the applicant will be notified via email. Depending upon the volume of pending requests, access may be granted the following business day, or can take up to 7 business days.

Per NRS 293.440(6)(b), any person, candidate, party or organization who receives information requested on this form is prohibited from using such information for purposes not related to an election and from selling such information for any reason.
