Please find attached the report for #5 for your request of names and addresses of requesters for the Voter registration database since November 3, 2020. These were submitted online and the report is the list of who requested the database.

The reports you requested for #1 and #2 of your request are too large to email. We can place these on a DVD and mail them to you. Which address would you like this mailed to?

Here is info for #3 and #4 of your request.

3. Records reflecting the total count, by county, of registered voters protected from public disclosure by RCW § 29A.08.720 or any other statute allowing the redaction or withholding of voter information from voter registration data, at the time of each of the following elections:

1. 2020 general = 33,223 future sign-ups were not currently registered voters at the time of the election. Registered voters that turned 18 on or before Election Day would not have been protected from disclosure on Election Day because they would have been 18.
 2. 2012-2018 general = 0. The legislation enacting future voter signups we into effect July 1, 2019.
4. Records reflecting the total count of ballots cast election wide, by county, by voters protected from public disclosure by RCW § 29A.08.720 or any other statute allowing the redaction or withholding of voter information from voter registration data, at the time of each of the following elections:
- a. 2020 general = 0. Registered voters that turned 18 on or before Election Day would not have been protected from disclosure on Election Day because they would have been 18.
 - b. 2012-2018 general = 0. The legislation enacting future voter signups we into effect July 1, 2019.
